MYTILINEOS HOLDINGS S.A. also announces that on the 29th of December 2005 transferred to its subsidiary "METAL CONSTRUCTIONS OF GREECE S.A." all shares of the company "ELEMKA? Technical, Constructing, Tourist, and Commercial Company S.A." which were in its possession? that is, three hundred and six (3.006) nominal shares, which amount to a 83.50% of its equity capital. This was done in the context of the Group's general restructure, and due to ELEMKA's more related object and activities with subsidiary "METAL CONSTRUCTIONS OF GREECE S.A.".
