DECISION

SUBJECT: Amendment to No.142429/12-7-2021 Environmental Terms Approval Decision of the project "Electric Transmission line (T.L..) of 400 kV for the connection of the Ag. Nikolaos High Voltage Substation with Distomo High Voltage Substation" in the Municipalities of Levadia and Distomo - Arachova - Antikyra of Viotia Region.

THE DEPUTY DIRECTOR-GENERAL FOR SPATIAL PLANNING AND ENVIRONMENTAL POLICY DECENTRALIZED ADMINISTRATION OF THESSALY AND CENTRAL GREECE

- 30. The fact that from the examination of the evidence submitted in the study file shows that, in the light of the proposed modifications to be made within areas not covered by the provisions of the forestry legislation, namely:
- The slight change in routing of the 400 kV power transmission line.

- The abolition of three (3) pillars and the construction of five (5) new ones.
- the removal of two (2) road sections of 315 m in length and the construction of three (3) new ones, a total length of approximately 675 m,

there is no substantial change in the environmental impact of the operation of the project; and therefore, no new Environmental Impact Assessment is required.

DECIDE

We are amending of No.142429/12-7-2021 our decision approving environmental terms of the project "Electric Transmission line (T.L..) of 400 kV for the connection of the Ag. Nikolaos High Voltage Substation with Distomo High Voltage Substation" in the Municipalities of Levadia and Distomo - Arachova - Antikyra of Viotia Region, replacing paragraph A as follows:

A. DESCRIPTION OF ACTIVITY

A.1) Type and size of activity

This Environmental Impact Study concerns the construction and operation of new 400 kV Electricity Transmission Line, Agios Nikolaos High Voltage Substation (HVS), - Distomo High Voltage Substation (HVS), for connecting the Agios Nikolaos High Voltage Substation (HVS) with the Distomo High Voltage Substation (HVS), in the context of the connection of the New 826 MW Agios Nikolaos Power Station with the National Electricity Transmission System (System), at Agios Nikolaos HVS. The new 400 kV Electricity Transmission Line will have a total length of approximately 14,06km and will consist of forty-four (44) High Voltage pylons.

The proposed in this study projects, concern the following:

- Construction of new 400 kV High Voltage Electricity Transmission Line of total length Approx. 14,06 km
- Construction of forty-four (44) new High Voltage pylons.
- Opening of forest roads, with a total length of approximately 9.160 m, to suit needs of the construction and operation of the new Electricity Transmission Line, including 7,294.61 meters located within woodland areas.
- ullet Development of an area of 1,265 square meters, for cabling systems under the terminal pylon (Π 42) of the Electricity Transmission Line
- Execution of works addition of equipment for the connection of cabling systems area, to the Agios Nikolaos High Voltage Substation (HVS).
- Connection of the new Electricity Transmission Line. with the Distomo High Voltage Substation (HVS) (connection of the terminal pillar of electricity transmission line, to the terminal scaffold, of the available portal in the Distomo High Voltage Substation (HVS).

The total intervention area within forest areas, is estimated at 80.728.83 sq. m.
